

**NOTICE OF HEARING**

**To Consider a Petition for the Creation of Hunt County Emergency Services District No. 1**

**TO: ALL PERSONS HAVING AN INTEREST IN THE CREATION OF THE HUNT COUNTY EMERGENCY SERVICES DISTRICT NO. 1**

**YOU ARE HEREBY ADVISED:** A Petition for the creation of an Emergency Services District has been received by County Judge Bobby W. Stovall and filed with Jennifer Lindenzweig, County Clerk in and for Hunt County, Texas containing an adequate number of signatures of full qualified voters owning taxable property in the area proposed for the Emergency Services District.

**YOU ARE HEREBY FUTHER ADVISED** the functions for the prosed Hunt County Emergency Services District will provide the emergency services set forth in Article III, Section 48-e, Texas Constitution, except for and specifically excluding emergency ambulance servcies.

**THE NAME OF THE PROPOSED EMERGENCY SERVICES DISTRICT** is Hunt County Emergency Services District No. 1.

**THE PROPOSED EMERGENCY SERVICES DISTRICT** is to be created and is to operate under Article III, Sec. 48-e of the Texas Constitution, as proposed by S.J.R. No. 27, Acts of the 70<sup>th</sup> Legislature, Regular Session, 1987, and adopted by the voters at an election held November 3, 1987 and Chapter 775, Texas Health & Safety Code.

**THE BOUNDARIES OF THE PROPOSED EMERGENCY SERVICES DISTRICT** are the entire territorial limits of Hunt County, Texas, save and except for the territorial limits for the City of Commerce, the City of Greenville, the City of Josephine and the City of Royse City, Texas as such existed as of July 1, 2019.

**YOU ARE HEREBY FURTHER ADVISED** that a public hearing shall be held by the Hunt County Commissioners Court on July 13, 2021 at 7:00 p.m. at the Greenville Municipal Auditorium, 2821 Washington St., Greenville, Texas, 75401, for the purpose of considering, discussing and/or acting upon the proposed creation of the Hunt County Emergency Services District No. 1. Each person who has an interest in the creation of the district here in above described may attend the hearing and present grounds for or against the creation of the district.
