

NOTICE OF FORECLOSURE SALE


4. Terms of Sale. The sale will be conducted as a public auction to the highest bidder for cash. 
5. Obligations Secured. The Deed of Trust executed by JERRY S. CAMP, provides that it secures the payment of the indebtedness in the original principal amount of \$82,000.00, and obligations therein described including but not limited to (a) the promissory note; and (b) all renewals and extensions of the note. Specialized Loan Servicing LLC is the current mortgagee of the note and deed of trust and SPECIALIZED LOAN SERVICING LLC is mortgage servicer.
