NOTICE OF ASSESSMENT LIEN SALE

WHEREAS, the real estate described on Exhibit "A" attached hereto (the "*Property*") is subject to the Declaration of Covenants, Conditions and Restrictions for Verandah, executed on December 20, 2007 and recorded under Document 20929, Book OR, Volume 1695, Page 288 *et seq.*, of the Official Public Records of Hunt County, Texas (the "*Declaration*") and any other applicable re-filings or re-plattings thereof and amendments or supplements thereto. The Declaration provides for the payment of assessments to **Verandah Homeowners' Association, Inc.** (the "*Association*") which is secured by a lien against the lot of the non-paying owner.



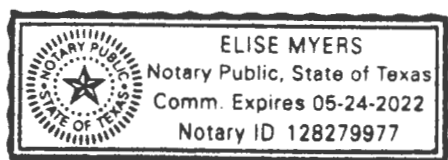


