

LEGAL DESCRIPTION**

All that certain lot, tract or parcel of land situated in the City of Greenville, Hunt County, Texas and being Lots, 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, and 11, Block A, of Pinegates Village according to the Plat thereof recorded in Cabinet G, Slide 247, Plat Records Hunt County, Texas.

Together with License Agreement recorded under document number 2014-12508, OPR Records Hunt County, Texas and being described as follows:

Being that certain 2,012 square feet (0.046 acre) tract of land situated in the John McGrew Survey, Abstract No. 687, City of Greenville, Hunt County, Texas, and being a portion of that certain tract of land to St. Louis & Southwestern Railway (recording information unknown), and being more particularly described as follows:

COMMENCING at a 1-1/2 inch iron pipe found in the south right-of-way line of said Railway (a called 100' right-of-way), same being the northeast corner of that certain tract of land to One Ranch View, Ltd., by deed recorded in Volume 722, Page 415, Deed Records, Hunt County, Texas, same being the northeast corner of that certain tract of land to Joe Day, by deed recorded in Volume 461, Page 272, said Deed Records;

THENCE South 85 deg. 48 min. 04 sec. West, along the common line of said One Ranch View tract and the south line of said Railway, a distance of 317.81 feet to a point for the southeast corner of the herein described tract, same being the POINT OF BEGINNING;

THENCE South 85 deg. 48 min. 04 sec. West, continuing along the common line of said One Ranch View tract, and the south line of said Railway, a distance of 20.12 feet to a point for the southwest corner of the herein described tract, same being the northwest corner of said One Ranch View tract, same being the northeast corner of that certain tract of land to One Ranch View Ltd by deed recorded in Volume 751, Page 66, aforesaid Deed Records;

THENCE North 02 deg. 10 min. 16 sec. East, through the interior of said Railway right-of-way a distance of 100.62 feet to a point for the northwest corner of the herein described tract from which a 1/2 inch iron rod found for the northeast intersection of the north right-of-way line of said Railway with the southeast right-of-way line of U.S. Highway No. 69 bears South 85 deg. 47 min. 44 sec. West, 824.29 feet, said corner being in the north right-of-way line of said Railway, same being in the south line of that certain tract of land to Pinegates, LLC, by deed recorded in County Clerk's File No. 2014-7455, Official Public Records, Hunt County, Texas;

THENCE North 85 deg. 47 min. 44 sec. East along the common line of said Railway, and said Pinegates tract, a distance of 20.12 feet to a point for the northeast corner of the herein described tract;

THENCE South 02 deg. 10 min. 16 sec. West, through the interior of said Railway right-of-way, a distance of 100.62 feet to the POINT OF BEGINNING and containing 2,012 square feet or 0.046 acre or computed land, more or less.
