THENCE South 06 degrees 07 minutes 16 seconds West, along the West line of said Kingston Road, a distance of 194.40 feet to a 3/8 inch iron rod found for corner, said corner being the Northeast corner of a tract of land conveyed to Harold F. Curtis, Jr., by deed recorded in Volume 795, Page 792, Deed Records of Hunt County, Texas;

South 80 degrees 21 minutes 02 seconds West, a distance of 87.55 feet to a 1/2 inch iron rod found for corner;

South 01 degree 37 minutes 21 seconds West, a distance of 171.00 feet to a 1/2 inch iron rod found for corner;

North 86 degrees 22 minutes 14 seconds East, a distance of 76.73 feet to a 3/8 inch iron rod found for corner, said corner being in the West line of said Kingston Street;

THENCE South 06 degrees 43 minutes 01 second West, along the West line of said Kingston Street, a distance of 29.39 feet to a 5/8 inch iron rod found for corner, said corner being the Northeast corner of a tract of land conveyed to Steve Harris, a married person, by deed recorded in Volume 917, Page 351, Deed Records of Hunt County, Texas;

THENCE South 89 degrees 10 minutes 55 seconds West, along the North line of said Harris tract, a distance of 75.25 feet to a point for corner, said corner being the Northwest corner of said Harris tract, from which a 5/8 inch square bolt found for witness bears North 54 degrees 05 minutes 27 seconds East, a distance of 2.03 feet;

THENCE South 06 degrees 45 minutes 17 seconds West, along the West line of said Harris tract, a distance of 144.92 feet to a 3/8 inch iron rod found for corner, said corner being the Southwest corner of said Harris Tract, and being in the North line of N. Rees Street (a Public right-of-way), and being the beginning of a non-tangent curve turning to the right, with a radius of 1382.40 feet, a delta angle of 22 degrees 33 minutes 21 seconds, a chord bearing of North 72 degrees 42 minutes 25 seconds West, and a chord length of 540.71 feet;

THENCE North 55 degrees 50 minutes 46 seconds West, along the Northeast line of said Rowlet tract, a distance of 115.25 feet to a point for corner, said corner being the North corner of said Rowlet tract, same being the East corner of a tract of land conveyed to Miguel Mendoza and Lilliana Salazar, by deed recorded in Instrument No. 2016-12500, Official Public Records of Hunt County, Texas;

THENCE North 64 degrees 47 minutes 06 seconds West, along the Northeast line of said Mendoza/Salazar tract, a distance of 105.34 feet to a point for corner;

THENCE North 68 degrees 58 minutes 19 seconds West, along the Northeast line of said Mendoza/Salazar tract, a distance of 36.93 feet to a point for corner, said corner being the North corner of said Mendoza/Salazar tract, and being the East corner of a tract of land conveyed to Nancy A. Mjelde, a single woman, by deed recorded in Instrument No. 2010-14416, Official Public Records of Hunt County, Texas;

THENCE North 57 degrees 14 minutes 42 seconds West, along the Northeast line of said Mjelde tract, a distance of 170.34 feet to a 3/8 inch iron rod found for corner, said corner being the North corner of said Mjelde tract, and being the East corner of a tract of land conveyed to Guillermo Castrejon, Ashley Castrejon, Gerado Castrejon, Jr., by deed recorded in Instrument No. 2015-5140, Official Public Records of Hunt County, Texas;

THENCE North 53 degrees 16 minutes 23 seconds West, along the Northeast line of said Castrejon tract, a distance of 82.87 feet to a 1/2 inch iron rod set with a yellow cap stamped "CBG Surveying" for corner, said corner being the North corner of said Castrejon tract, same being the Southeast corner of a tract of land conveyed to K & G Builders Inc., by deed recorded in Instrument No. 2019-18864, Official Public Records of Hunt County, Texas, and being the Southwest corner of a tract of land conveyed to Luis Ruben Espinosa, by deed recorded in Instrument No. 2019-01008, Official Public Records of Hunt County, Texas, from which a 1/2 inch iron rod found for witness bears North 35 degrees 06 minutes 42 seconds East, a distance of 0.66 feet;

THENCE North 88 degrees 41 minutes 45 seconds East, along the South line of said Espinosa tract, a distance of 71.14 feet to a 1/2 inch iron rod found for corner, said corner being the Southeast corner of said Espinosa tract, and being the Southwest corner of a tract of land conveyed to Ralph W. Hollis and wife, Connie L. Hollis, by deed recorded in Volume 312, Page 244, Deed Records of Hunt County, Texas;

THENCE North 89 degrees 48 minutes 23 second: East, along the South line of said Hollis tract, a distance of 888.21 feet to the POINT OF BEGINNING and containing 302,526 square feet or 6.95 acres of land.
