



#### CONTRACT FOR CITATION FILING SERVICES

#### STATE OF TEXAS

#### COUNTY OF HUNT

THIS CONTRACT is made and entered into by and between HUNT County acting herein by and through its governing body, hereinafter called County, and NET Data hereinafter called NET Data for the purpose of acquiring NET Data's iticket services hereinafter called iticket.

I.

County agrees to employ and does hereby employ NET Data to electronically file citations, issued in County and provided by the Texas Department of Public Safety, to County's Justice of the Peace Court(s) software system pursuant to the terms and conditions described in this contract. This contract supercedes all prior oral and written agreements concerning citation filing services between the parties, and can only be amended if done so in writing and signed by all parties. Furthermore, this contract cannot be transferred or assigned by either party without the written consent of all parties.

II.

County agrees to allow NET Data to upload citations into its Justice Court(s) software system. County will provide NET Data with access to said software system through adequate ports and bandwidth necessary for FTP and Telnet transmissions.

III.

County agrees to pay NET Data a fee of \$2 for each case filed as the result of a citation uploaded by and through iticket. County shall remit payment to NET Data on a monthly basis by check.

IV.

This contract shall commence on \_\_\_\_\_\_\_, 2011 and be in effect for a period of three (3) years, after which it shall automatically renew on an annual basis. Either party to this agreement shall have the right to terminate this agreement after the initial term by giving the other party thirty (30) days written notice of their desire and intention to terminate this agreement.

V.

This contract is made and is to be interpreted under the laws of the State of Texas. Venue for any disputes involving this contract shall be in the appropriate courts in Hopkins County, Texas.

VI.

In consideration of the terms and compensation herein stated, NET Data hereby accepts said contract and undertakes performance of said contract as set-forth above.

#### VII.

Every provision of this Agreement is intended to be severable. If any term or provision hereof is hereafter deemed by a Court to be illegal, invalid, void or unenforceable, for any reason or to any extent whatsoever, such illegality, invalidity, or unenforceability shall not affect the validity of the remainder of this Agreement, it being intended that such remaining provisions shall be construed in a manner most closely approximating the intention of the Parties with respect to the illegal, invalid, void or unenforceable provision or part thereof.

This contract is executed on behalf of County by the presiding officer of its governing body who is authorized to execute this instrument by order heretofore passed and recorded in its minutes.

This contract may be executed in any number of counterparts, and each counterpart shall be deemed an original for all purposes. Signed facsimiles shall be binding and enforceable.
