PROPOSED SPENDING

LINE 1 - INVESTIGATIVE SUPPORT: polygraphs, video and audio tapes, expert services at crime scenes etc. = **\$15,000**

LINE 2 - GENRAL OPERATING EXPENSES: undercover expenses, crime scene expenses, crime scene equipment, photographs, diagrams, maps, etc = **\$35,000**

LINE 3 - EQUIPMENT: firearms, ballistics vests, flashlights, vehicles, and other tools as may be needed at crime scenes etc. = **\$110,698.11**

LINE 4 - MISCELLANEOUS = **\$2,500**

LINE 5 - ERRORS AND OMMISIONS = **\$1,000**

LINE 6 - SALARY STIPENDS: to include cell phone stipends, certificate pay, salary adjustments and K9 = **\$108,175**

LINE 7 - EDUCATION: community events, internships, SO Academy = **\$10,000**

BE IT REMEMBERED, that the Commissioners Court of Hunt County, Texas previously adopted a plan for the redistricting of Commissioners Court Precincts. As a consequence of the boundary modifications made by that Order, various changes in the underlying election precincts were required to conform election precinct boundaries to the new Commissioners Court precincts. In addition, the resulting changes to election precincts may have an impact upon the Justice of the Peace Precinct(s) of Hunt County. This Supplemental Order, and the attached maps, data and narrative text, set forth the changes resulting from redistricting of Commissioners Court precincts, and provide an explanation for the necessity of the same.

IT IS THEREFORE ORDERED, ADJUDGED and DECREED that this Supplemental Order, along with all prior Orders of the Commissioners Court, shall be considered as a whole, and this Order shall constitute the FINAL ORDER of the Hunt County Commissioners Court regarding redistricting of all Hunt County political boundaries. To the extent necessary for a complete submission to the United States Department of Justice, as required by Section 5 of the Voting Rights Act, 42 U.S.C. §1973, this Order may be supplemented by such attachments and additional data as may be required by that statute without the necessity of further action by the Commissioners Court.

Legal Counsel for the County, the firm of Allison, Bass & Associates, LLP, is authorized to make such necessary additions to this Order to comply with the requirements of federal law, or the requests of Department of Justice pre-clearance reviewers.

This Supplemental Order shall be composed of the following information:


1. Map of Commissioners Court precincts and description of census blocks included therein, physical description of boundaries, constituent election precincts, and demographic data.
2. A list of polling place addresses for each Election Precinct.
3. Map of each Election Precinct and description of census blocks included therein, physical description of boundaries and demographic data.
4. Map of each Justice of the Peace Precinct and description of census blocks included therein, physical description of boundaries, constituent election precincts, and demographic data.
5. If necessary, a narrative explanation of any boundary definition that is not sufficiently depicted in map form.
6. If necessary, a narrative explanation of any other condition or circumstance relevant to the redistricting of Hunt County political boundaries.

Notice of Availability: A copy of the entire submission to the United States Department of Justice shall be available for inspection by the public during regular business hours in the office of the Hunt County Clerk. The public is invited to make comment upon the plan with the Department of Justice. Comments should be addressed to the Chief, Voting Section, Civil Rights Division, Department of Justice, 320 First Street NW, Room 818A, Washington, D.C. 20001.


IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Redistricting Plan depicted in the maps and data attached to this Order are hereby APPROVED and ADOPTED by the Commissioners Court of Hunt County, Texas. This Final Order shall, in substance, constitute the submission for new political boundaries to the United States

Department of Justice pursuant to Section 5 of the Voting Rights Act of 1964, 42 U.S.C. §1973. The Redistricting Plan adopted by this Order shall be effective, subject to Department of Justice preclearance, on January 1, 2012, and for all subsequent elections until changed or modified by later Order. It is expressly understood that implementation of this plan shall not take place until the receipt of preclearance approval by the United States Department of Justice.





RESOLUTION # 12,142

**A RESOLUTION OF THE HUNT COUNTY COMMISSIONERS COURT
PROHIBITING ALL OUTDOOR BURNING WITH EXCEPTIONS AS
SPECIFIED IN THIS RESOLUTION.**

WHEREAS, the Commissioners Court of Hunt County, Texas, finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning;

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Commissioners Court of Hunt County, Texas that all outdoor burning is prohibited in the unincorporated area of the county for 90 days from the date of adoption of this Resolution, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service and this Court. This Resolution is adopted pursuant to the Local Government Code §352.081, and other applicable statutes. This Resolution does not prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Commission on Environmental Quality for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting of crops; or, (4) burns that are conducted by a prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code. This Resolution also does not prohibit the use of welders, cutting torches, and similar tools and machinery, nor does this Resolution prohibit any outdoor cooking activity.

In accordance with Local Government Code §352.081(h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.00.

WHEREAS, the Program rules require the County to approve the Organization's accounting system or fiscal agent, in order for the Organization to be eligible to receive Program grant funds.






SECTION 2: The County hereby certifies that the Organization provides home-delivered meals to homebound persons in the County who are elderly and/or have a disability.







**A RESOLUTION OF THE HUNT COUNTY COMMISSIONERS COURT,
PROVIDING FOR THE TAXATION OF GOODS-IN-TRANSIT; PROVIDING A
REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE: AND
PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, Senate Bill 1 passed by the 82nd Texas Legislature, First Called Special Session, *inter alia*, amended Section 11.253, Tax Code regarding the exemption for “Goods-in-Transit; and

WHEREAS; Section 11.253, Tax Code, was amended to prohibit a taxing unit from taxing Goods-in-Transit in a tax year that begins on or after January 1, 2012, unless the governing body of the taxing unit takes action on or after October 1, 2011, to provide for the taxation of the Goods-in-Transit; and

WHEREAS, the governing body is required by the new legislation to take action to tax Goods-in-Transit after public hearing even if the governing body previously took action to tax Goods-in-Transit; and

WHEREAS, the governing body may choose to opt out of the local exemption for Goods-in-Transit by holding a public hearing and taking action to continue tax such goods on or after October 1, 2011, but prior to January 1, 2012; otherwise, such property will be exempt from taxation; and

WHEREAS, the governing body desires to continue to tax Goods-in-Transit beginning tax year 2012; and

WHEREAS, the governing body has conducted a public hearing as required by Section 1-n (d), Article VIII, Texas Constitution, at which citizens were provided an opportunity to speak;


NOW, THEREFORE, BE IT RESOLVED by the Commissioners Court of the County of Hunt:

SECTION 1. That beginning tax year 2012, and continuing thereafter until further action is taken by the governing body, “Goods-in-Transit”, as defined by Tax Code, Section 11.253, shall be subject to property taxation by the County of Hunt.


SECTION 2. That should any sentence, paragraph, subdivision, clause, phrase or section of this Resolution be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this Resolution as a whole or any part or provision thereof other than the part thereof decided to be unconstitutional, illegal or invalid.

SECTION 3. That this Resolution shall take effect immediately from and after its passage.







WHEREAS, domestic violence includes not only physical abuse, but also mental abuse, emotional abuse, financial abuse, isolation, and sexual violence, and,


