The Term of this Agreement was for the period beginning on August 1, 2011 and expiring on July 31, 2012.

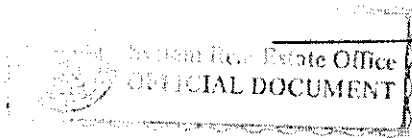

RLSS/LPHS contracts are based on expected state appropriations and federal funding levels and are contingent on continued availability of funding. With the PHHSBG not funded in the President's federal fiscal year 2013 (FFY13) budget, we have yet to receive any information from the Centers for Disease Control and Prevention about the level of PHHSBG funding to expect in FFY 2013. Therefore, DSHS Regional and Local Health Services will process FY13 contracts under the assumption that the PHHSBG will potentially be zero-funded in FFY13. Adjustments to contracts may be necessary depending on the final budget appropriation of the PHHS block grant.
