



AMENDMENT TO INTERLOCAL AGREEMENT

THIS AMENDMENT (this "Amendment") is entered into effective the _____, 2013 (the "Effective Date"), by and between the **BOARD OF REGENTS OF THE TEXAS A&M UNIVERSITY SYSTEM** ("TAMUS"), an agency of the State of Texas, for the use and benefit of the Texas A&M Forest Service ("TFS"), and the **COUNTY OF HUNT** (the "COUNTY"), a Texas local governmental entity, for the purpose of amending an Interlocal Agreement dated August 6, 2011, governing the lease of 600 square feet of office space in Room #469, situated in the Hunt County Courthouse located at 2801 Stuart Street, Greenville, Hunt County, Texas, as amended August 1, 2012, to extend the term (the "Agreement").

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, TAMUS and the COUNTY hereby agree as follows:

1. Exclusive Use. Section 1.01 of the Agreement is hereby amended to reflect the correct location of the Premises:

Approximately 600 square feet of net usable office space, Room #469, as designated by the COUNTY, and situated in the Hunt County Sheriff's Department, located at 2801 Stuart Street, Greenville, Hunt County, Texas 78636.

2. Term. In accordance with Section 2.01 of the Agreement, TAMUS is exercising its second (2nd) of four (4) options to renew the Agreement for an additional 12-month period, beginning August 1, 2013, and continuing through July 31, 2014.

3. Counterparts. This Amendment may be executed in several counterparts, each of which shall be fully effective as an original, and all of which together shall constitute one and the same instrument.


4. Binding Effect. This Amendment shall be binding upon and inure to the benefit of and be enforceable by the parties hereto and their respective successors and assigns.

5. Other Terms. Except as expressly provided herein, all of the terms and conditions of the Agreement and any and all other documents described in or executed in connection with the Agreement shall continue in full force and effect and are hereby reaffirmed.


