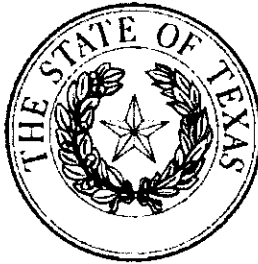

WHEREAS, in both war and peace, these words have been a profound source of strength and guidance to many generations of Americans; and


WHEREAS, the county desires to display this patriotic motto in the Commissioners' Court as a way to solemnize public occasions and express confidence in our society.
