Dear Judge Horn,

The election for the Hunt County Appraisal District Board of Directors for the 2018 – 2019 term will be conducted this year. The first step in this process is for the taxing entities to submit their nominations. Each taxing entity may nominate up to seven candidates. Nominations must be by resolution adopted by the governing body of the entity. The names of the nominees must be submitted to the chief appraiser **ON OR BEFORE OCTOBER 15, 2017**. Any nominations received after this date cannot be accepted.

Once all nominations have been submitted and prior to October 30, 2017, the appraisal district will mail you a ballot listing each candidate alphabetically. At that time, the governing body may cast its votes by resolution and submit the resolution to the chief appraiser before December 15, 2017. The governing body may cast all its votes for one candidate or may distribute their votes among any number of candidates.

Attached is a listing of the taxing entities within Hunt County who are eligible to participate in this election along with their entitled number of votes.

To be eligible to serve as a director, an individual must be a resident of the district and must have resided in the district for two years. An employee of a taxing unit that participates in the district is not eligible to serve unless that person is also a member of the governing body or is an elected official of a taxing unit that participates in the district.

Please submit your nominee(s) by resolution **on or before October 15**.
