
ORDER



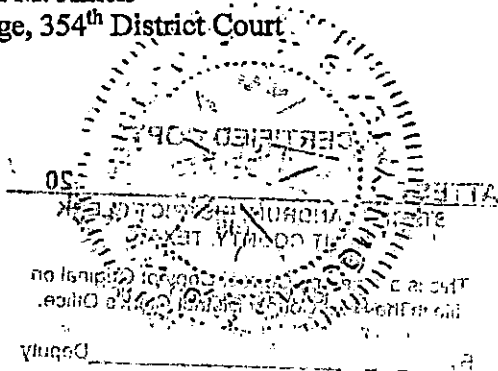
