**WHEREAS**, on this the 27<sup>th</sup> day of August, 2019, the Commissioners' Court of Hunt County Texas, convened in REGULAR SESSION with the following members present:

- Eric Evans-Commissioner, Pct. #1
- Randy Strait-Commissioner, Pct. #2
- Phillip Martin-Commissioner, Pct. #3
- Steven Harrison-Commissioner, Pct. #4

**AND WHEREAS**, the matter brought before the Court was the setting of a tax rate as required by Article 26.05, Texas Tax Code;

**AND WHEREAS**, after notice and hearing, the following motion was offered by Commissioner \_\_\_\_\_ and seconded by Commissioner \_\_\_\_\_: "I move that the property tax be increased by the adoption of a tax rate of .508512, which is effectively a 7.26 percent increase in the tax rate for the 2019 tax year."

The tax rate for the **YEAR 2019** is computed as follows:

General Fund	0.396016
FMLR Fund	<u>0.100000</u>
Total Maintenance & Operating	0.496016
Debt Service Fund	0.012496
<b>Total All Funds</b>	<b>0.508512</b>

The above rates are per \$100 of assess valuation

**THIS RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**

**THE TAX RATE FOR MAINTENANCE AND OPERATIONS WILL EFFECTIVELY BE RAISED BY 1.11 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$5.53.**

The above rates are per \$100 of assess valuation


