







Texas Property Tax Code § 6.231

(a) A county assessor-collector must successfully complete 20 hours of continuing education before each anniversary of the date on which the county assessor-collector takes office. The continuing education must include at least 10 hours of instruction on laws relating to the assessment and collection of property taxes for a county assessor-collector who assesses or collects property taxes.

(d) A county assessor-collector shall file annually a continuing education certificate of completion with the commissioners' court of the county in which the county assessor-collector holds office.

ORDER AWARDING POSSESSION OF PROPERTY

WHEREAS, on the 23rd day of August, 2019 in the Justice Court of Precinct 1, Place 1, Hunt County, Texas, came INVESTIGATOR JOSH ROBINSON, a Peace Officer with the HUNT COUNTY SHERIFFS DEPARTMENT seized the following property: YELLOW AND BLACK DEWALT GENERATOR DXGNR7000, MODEL # PM0167000.02, S/N 3002431993, now in the control of INVESTIGATOR JOSH ROBINSON, a Peace Officer with the HUNT COUNTY SHERIFFS DEPARTMENT. Said property is to be held by HUNT COUNTY SHERIFFS DEPARTMENT until a determination is made by a court having jurisdiction to the possession or proper disposition of the property

All parties expressing a claim to possession having been properly notified of this examining trial, and those desiring to assert such claim to possession having not appeared in person or through their attorney, the court, after hearing all the evidence and testimony, find that no criminal action regarding this property is pending and is of the opinion that the possession of the above described property should be awarded to HUNT COUNTY SHERIFFS DEPARTMENT whose mailing address is 2801 STUART ST GREENVILLE TX 75401.

THEREFORE IT IS ORDERED that the possession of this property now in the possession and control of INVESTIGATOR JOSH ROBINSON, a Peace Officer with the HUNT COUNTY SHERIFFS DEPARTMENT be immediately transferred to HUNT COUNTY SHERIFFS DEPARTMENT, subject to the condition that such property shall be made available to the State should it be needed in further prosecutions, or that any court having jurisdiction over the offense may order the property to be used for evidentiary purposes; and furthermore the court finds that:

no storage charges are currently due at this time,
 storage charges in the amount of \$ _____ are currently due and owing to _____; accordingly, it is ORDERED that Claimant shall pay such charges before the property so awarded may be transferred to Claimant.
