AGREED JUDGMENT OF FORFEITURE

On this the 6TH day of November, 2019, came on to be heard the above-styled and numbered cause. The State of Texas appeared by and through its District Attorney in and for Hunt County, Texas. Respondent, BRETTNEE JO LOCKE having been duly cited to appear and answer herein, appeared by submission through her counsel of record, FREDERICK C. SHELTON. A jury is waived and all matters of fact and things in controversy are submitted to the Court. The Parties announce to the Court that they have reached an agreement, and ask the Court to approve the same. It appears to the Court that the said agreement is just and right, and it further appears that the Court has jurisdiction of the subject matter and the necessary parties. Therefore, said agreement is hereby approved.

The Court finds that the parties have agreed that Respondent, BRETTNEE JO LOCKE is the registered owner of the 2009 CHEVROLET 4 DR PASS VEHICLE, VIN 1G1AT58H497285558 the subject of this forfeiture proceeding. The Court finds that 2009 CHEVROLET 4 DR PASS VEHICLE, VIN 1G1AT58H497285558 is subject to forfeiture pursuant to Chapter 59 of the Code of Criminal Procedure.

It is therefore ORDERED, ADJUDGED, and DECREED by this Court that any and all interest of, BRETTNEE JO LOCKE, Respondent, in the 2009 CHEVROLET 4 DR PASS VEHICLE, VIN 1G1AT58H497285558 is hereby forfeited to the State of Texas, to be distributed in accordance with Article 59.06 of the Code of Criminal Procedure and local agreement between the parties.

The Texas Department of Transportation, Motor Vehicle Department is directed to issue good and sufficient title to such vehicle such that will perfect title in the Greenville Police Department and any subsequent purchaser for said agency.

It is further ORDERED, ADJUDGED, and DECREED that all costs are assessed against the party incurring same. All other relief not expressly granted herein is denied.






