WHEREAS, on this the 15<sup>th</sup> day of August, 2020, the Commissioners' Court of Hunt County Texas, convened in a PUBLIC HEARING with the following members present:

- Bobby W. Stovall-County Judge
- Eric Evans-Commissioner, Pct. #1
- Randy Strait-Commissioner, Pct. #2
- Phillip Martin-Commissioner, Pct. #3
- Steven Harrison-Commissioner, Pct. #4

AND WHEREAS, the matter brought before the Court was the setting of a tax rate as required by Article 26.05, Texas Tax Code;

AND WHEREAS, after notice and hearing, the following motion was offered by Judge Stovall and seconded by Commissioner Martin:

"I move that the property tax be decreased by the adoption of a tax rate of .467017, which is effectively an 8.16 percent decrease in the tax rate for the 2020 tax year."

The tax rate for the YEAR 2020 is computed as follows:

General Fund	0.355806
FMLR Fund	<u>0.100000</u>
Total Maintenance & Operating	0.455806
Debt Service Fund	0.011211
<b>Total All Funds</b>	<b>0.467017</b>

The above rates are per \$100 of assess valuation


**THIS RATE WILL LOWER TAXES COMPARED TO LAST YEAR'S TAX RATE.**


