RESOLUTION NO. #16,559

**A RESOLUTION OF THE COMMISSIONERS' COURT OF HUNT COUNTY, TEXAS, APPROVING PAYMENT FOR SIGNAGE FOR THE JOHN L. HORN MEMORIAL PARKWAY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Judge John L. Horn began his judgeship in 2007, and as county judge, served as president of the North Central Texas Council of Government's Executive Board, served on the Texas Association of Regional Councils and the North Central Texas Housing Finance Commission; past president of the Hunt County Alliance for Economic Development; chairman of the Regional 911 Advisory Committee; and member of the Presidents Board of Workforce Solutions of North Texas; and

**WHEREAS**, Judge John L. Horn was also co-chairman of the Hunt County Transportation Plan Committee which began mapping out the county's future transportation needs in 2010; and

**WHEREAS**, the untimely death of Judge John L. Horn on September 2, 2018, after a very sudden illness, has left family, friends, and co-workers at a loss; and

**WHEREAS**, one of the major projects the committee recommended under the leadership of Judge John L. Horn was the extension of the existing FM 1570 to US Highway 380 southwest of Greenville; and

**WHEREAS**, the Hunt County Commissioners' Court sought to have a portion of FM 1570 named for Judge John L. Horn to recognize his hard work and willingness to serve others.

**WHEREAS**, the Texas House of Representatives and the Texas State Senate passed and approved House Bill 310 in 2019 naming portions of FM 1570 after Judge Horn;

**WHEREAS**, the County has been working with the City of Greenville and TxDOT to ensure that directional signage is erected on Interstate 30 and State Highway 380, and the City of Greenville has endeavored to annex currently unincorporated portions of TxDOT's right of way at the intersections of those roads and FM 1570 in a process that is expected to be complete within the 2020-2021 budget year;

**WHEREAS**, the Hunt County Commissioners' Court has received estimates for these signs from TxDOT;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS' COURT OF HUNT COUNTY, TEXAS, THAT:**

**SECTION 1.** The Hunt County Commissioners' Court hereby approves payment of signage for the John L. Horn Memorial Parkway as referenced in Exhibit "A."


**SECTION 2.** The Hunt County Judge is hereby granted the authority to enter into an interlocal agreement with the City of Greenville or TxDOT to accomplish the purchase and erection of the signs after the incorporation and renaming efforts of the City have been completed.



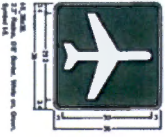
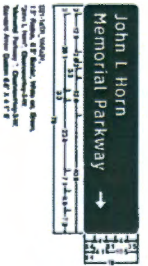
