AN ORDER OF THE HUNT COUNTY COMMISSIONERS COURT APPOINTING AN ELECTIONS ADMINISTRATOR DESIGNEE

WHEREAS, Chapter 31 of the Texas Election Code provides that a County Election Commission shall be established to include the county judge, county clerk, and county tax assessor-collector and the county chair of each political party that made nominations by primary election for the last general election for state and county officers;

WHEREAS, the Hunt County Commissioners Court has established a County Election Commission;

WHEREAS, the position of Elections Administrator is necessary to perform those duties set forth and described in Chapter 31 and particularly Section 31.043 and Section 31.044 of the Texas Election Code;

WHEREAS, The position of Hunt County Elections Administrator was be established by the Commissioners Court effective March 23, 2021 to assume the performance of the duties described in Texas Elections Code §31.043 and §31.044; and

WHEREAS, the appointment of an Elections Administrator Designee is necessary to assist with the assumption and performance of the duties set forth and described in Chapter 31 of the Texas Election Code, until an Elections Administrator is appointed.

THEREFORE, BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS COURT OF HUNT COUNTY, TEXAS that:

**Section 1. Findings Incorporated.** That the findings and premises contained in the preamble above are hereby deemed to be true and correct.

**Section 2. Elections Administrator.** Jeanie Ash is qualified to serve, she is hereby appointed as the Hunt County Elections Administrator Designee until the appointment of Hunt County Elections Administrator is made by the Hunt County Elections Commission.

**Section 3. Notice of Appointment.** Within three days of the date of this Order, the County Clerk shall deliver a copy of this Order by certified mail to the Secretary of State and appointed members of the Hunt County Elections Commission.

**Section 4. Severability.** If any provision of this Order or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Order and the application of such provision to other persons and circumstances shall nevertheless be valid, and the Court hereby declares that this Order would have been enacted without such invalid provision.


**Section 5. Authorization to Execute.** The County Judge is authorized to execute and the County Clerk is authorized to attest this Order on behalf of the Court.


