

\$ INTERLOCAL COOPERATION AGREEMENT BY AND

BECKY LANDRUM

This agreement (the "Agreement") is by and between the Hunt County Appraisal District, a political subdivision of the State of Texas ("HCAD"), and Hunt County, Texas a political subdivision of the State of Texas ("County") (each a "Party" and collectively the "Parties"), acting by and through their respective authorized representatives.

WITNESSETH:

WHEREAS, HCAD is charged with appraising property and administering exemptions for ad valorem tax purposes for Hunt County, Texas and has certain map data that is used for internal appraisal district purposes including the appraisal of property for ad valorem taxation; and

WHEREAS, COUNTY voter registration office desires to have access to HCAD maps, map data including shapefiles (collectively the "Map Records") for redistricting purposes (the "Purpose"); and

WHEREAS, the Parties desire to enter this Interlocal Cooperation Agreement to provide the COUNTY voter registration office access to, and use of for the Map Records; and

WHEREAS, the Interlocal Cooperation Act, Texas Government Code, Chapter 791 (the "Act") authorizes any local governments to contract with one or more other local governments to perform governmental functions and services under the terms of the Act; and

WHEREAS, each Party paying for the performance of governmental functions or services hereunder shall make those payments only from current revenues or other funds legally available to the paying Party;

NOW, THEREFORE, upon and for the mutual consideration stated herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

Article I. Definitions

Whenever used in this Agreement, the following terms shall have the following meaning ascribed to them:

"HCAD" shall mean the Hunt County Appraisal District acting by and through the Chief Appraiser.

"COUNTY" shall mean the Hunt County, Texas.

"Effective Date" shall mean the last date of execution hereof.

"Map Records" shall have the meaning assigned in the Recitals.

Article II Term

- 2.1 This term of this Agreement shall be for a period of one (1) year beginning on the Effective Date and shall automatically renew thereafter for successive periods of one (1) year, unless sooner terminated as provided herein.
- 2.2 Either Party may terminate this Agreement by providing thirty (30) days prior written notice thereof to the other Party.
- 2.3 This Agreement may be terminated upon written notice by either Party in the event the other Party breaches any of the terms or conditions of this Agreement and such breach is not cured within thirty (30) days after written notice thereof.

Article III Purpose

The purpose of this Agreement is set forth in the Recitals.

Article IV Use of Map Records

Licensed Access. HCAD does hereby grants a non-exclusive revocable license to COUNTY for the voter registration office to have access and use the Map Records for the limited purpose of redistricting. Access and use of the Map Records are provided by HCAD "AS IS" with all faults and HCAD disclaims all warranties, whether express, implied, statutory, and fitness for a particular purpose or otherwise. HCAD expressly disclaims: (i) that the Map Records are error free: (ii) the accuracy of any of the data contained in the Map Records; and (iii) whether such data and the Map Records are fit for the purpose of the County voter registration office using such data and the Map Records in connection with County redistricting. County assumes all risk of use of the Map Records and any inaccurate or incorrect data contained therein.

Article V Release/Immunity

5.1 <u>Release.</u> County does hereby release HCAD, its officers, agents, and employees (collectively "HCAD") from and against all claims or causes of action for injuries (including

death), property damages (including loss of use), and any other losses, demands, suits, judgments, and costs, including reasonable attorney's fees and expenses, in any way arising out of, related to, or resulting from the County access and use of the Map Records.

5.2 It is expressly understood and agreed that, in the execution of this Agreement, no Party waives, nor shall be deemed hereby to have waived any immunity or defense that would otherwise be available to it against claims arising in the exercise of governmental powers and functions. By entering into this Agreement, the Parties do not create any obligations, express or implied, other than those set forth herein, and this Agreement shall not create any rights in Parties not signatories hereto.

Article VI Miscellaneous

- 5.1 <u>Binding Agreement; Assignment.</u> The terms and conditions of this Agreement are binding upon the successors and assigns of all Parties hereto. This Agreement may not be assigned without the prior written consent of the other Party.
- 5.2 <u>Notices</u>. Any notice required or permitted to be delivered hereunder shall be deemed received: (i) three days after deposit in the United States Mail, postage prepaid, certified mail, return receipt requested, addressed to the Party at the address set forth below; or (ii) on the day received if sent by courier or otherwise hand delivered to the following addresses or such other address as such Party may designate from time to time:

- 5.4 <u>Legal Construction</u>. In the event any one or more of the provisions contained in this Agreement are for any reason held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability will not affect other provisions, and it is the intention of the Parties to this Agreement that in lieu of each provision that is found to be illegal, invalid, or unenforceable, a provision be added to this Agreement which is legal, valid and enforceable and is as similar in terms as possible to the provision found to be illegal, invalid or unenforceable.
 - 5.5 <u>Recitals</u>. The recitals to this Agreement are incorporated herein.
- 5.6 <u>Counterparts</u>. This Agreement may be executed in counterparts. Each of the counterparts shall be deemed an original instrument, but all the counterparts shall constitute one and the same instrument.
- 5.7 <u>Exhibits</u>. Any exhibits to this Agreement are incorporated herein by reference for all purposes wherever reference is made to the same.
- 5.8 <u>Amendment</u>. This Agreement may be amended by the mutual written agreement of the Parties to it.
- 5.9 <u>Authorization</u>. Each Party represents that it has full capacity and authority to grant all rights and assume all obligations that are granted and assumed under this Agreement. This Agreement was approved by order of the Commissioners Court of Hunt County, Texas.
- 5.10 <u>Survival of Covenants</u>. Any of the representations, warranties, covenants, and obligations of the Parties, as well as any rights and benefits of the Parties, pertaining to a period of time following the termination of this Agreement shall survive termination.
- 5.11 <u>Entire Agreement</u>. This Agreement is the entire Agreement between the Parties with respect to the subject matter covered in this Agreement. There is no other collateral oral or written agreement between the Parties that in any manner relates to the subject matter of this Agreement, except as provided in any Exhibits attached hereto.
