A RESOLUTION OF THE HUNT COUNTY COMMISSIONERS COURT Clerk, Hunt County ALLOCATING VOTES TO HUNT COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS NOMINEES.

**WHEREAS**, pursuant to Texas Property Tax Code, Section 6.03 (d), Hunt County is entitled to 1,785 votes to be allocated to Hunt County Appraisal District Board of Directors Nominees; and

**WHEREAS**; pursuant to Texas Property Tax Code, Section 6.03 (k), this vote must be submitted by virtue of resolution to the Chief Appraiser no later than December 15<sup>th</sup>; and

*WHEREAS*, on September 28, 2021, by Court Order #17,032, the Commissioners Court of Hunt County voted to nominate Tyson Cox, Paul Painter, Mitch Moore, John Sands, Steven Stone, Mike Taylor, and Howard Winans for the final Board of Directors ballot 2022 – 2023 term.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners Court of the County of Hunt:

**SECTION 1**. That <u>600</u> of Hunt County's votes be allocated to Tyson Cox for election to the Hunt County Appraisal District Board of Directors.

<u>SECTION 2</u>. That <u>100</u> of Hunt County's votes be allocated to Paul Painter for election to the Hunt County Appraisal District Board of Directors.

**SECTION 3**. That <u>loo</u> of Hunt County's votes be allocated to Mitch Moore for election to the Hunt County Appraisal District Board of Directors.

SECTION 4. That 300 of Hunt County's votes be allocated to John Sands for election to the Hunt County Appraisal District Board of Directors.

**SECTION 5**. That <u>O</u> of Hunt County's votes be allocated to Steven Stone for election to the Hunt County Appraisal District Board of Directors.

SECTION 6. That 400 of Hunt County's votes be allocated to Mike Taylor for election to the Hunt County Appraisal District Board of Directors.


SECTION 7. That 285 of Hunt County's votes be allocated to Howard Winans for election to the Hunt County Appraisal District Board of Directors.
