## Notice of Foreclosure Sale

1. *Property to Be Sold.* The Property to be sold is described as follows:  
  
Being 15.052 acres of land situated in the George Pollett Survey, Abstract No. 821 and in the W.B. Humphreys Survey, Abstract No. 1335, Hunt County, Texas being more fully described in the Exhibit "A" attached hereto and made a part hereof as though fully copied herein.
2. *Instrument to be Foreclosed.* The instrument to be foreclosed is the Deed of Trust executed by Jose Luis Rubio and Herendira Martinez, dated May 10, 2019 to Larry W. Green, Trustee for Beneficiary, Robert John Crowell, recorded under Document No. 2019-06629, Official Public Records of Hunt County, Texas.
3. *Date, Time, and Place of Sale.* The sale is scheduled to be held at the following date, time, and place:  
  
Date: May 6, 2025  
  
Time: The sale will begin no earlier than 10:00 a.m. or no later than three hours thereafter. The sale will be completed by no later than 1:00 p.m.  
  
Place: North steps of courthouse, including hallway area 20 feet inside north door on second floor, located at 2507 Lee Street, Greenville, Texas or as designated by the County Commissioners.

The Deed of Trust permits the Beneficiary to postpone, withdraw, or reschedule the sale for another day. In that case, the Trustee or Substitute Trustee under the Deed of Trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. The reposting or refileing may be after the date originally scheduled for this sale.

The Beneficiary has duly appointed in writing, by an Appointment of Substitute Trustee dated April 8, 2025, filed of record under Document No. 2025-06120, Official Public Records of Hunt County, Texas, Larry W. Green, Jr., and his assigns, as Substitute Trustee under the Deed of Trust.

4. *Terms of Sale.* The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the Deed of Trust permitting the Beneficiary thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the Deed of Trust at the time of sale.

Those desiring to purchase the Property will need to demonstrate their ability to pay their bid immediately in cash if their bid is accepted.

The sale will be made expressly subject to any title matters set forth in the Deed of Trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the Property, if any, to the extent that they remain in force and effect and have not been subordinated to the Deed of Trust. The sale shall not cover any part of the Property that has been released of public record from the lien of the Deed of Trust. Prospective bidders are strongly urged to examine the applicable Property records to determine the nature and extent of such matters, if any.

Pursuant to the Deed of Trust, the Beneficiary has the right to direct the Trustee to sell the Property in one or more parcels and/or to sell all or only part of the Property.

Pursuant to Section 51.009 of the Texas Property Code, the Property will be sold in "as is, where is" condition, without any express or implied warranties, except as to the warranties of title (if any) provided for under the Deed of Trust. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the Property.

Pursuant to Section 51.0075 of the Texas Property Code, the Trustee reserves the right to set further reasonable conditions for conducting the sale. Any such further conditions shall be announced before bidding is opened for the first sale of the day held by the Trustee or any Substitute Trustee.

5. *Type of Sale.* The sale is a nonjudicial deed-of-trust lien and security interest foreclosure sale being conducted pursuant to the power of sale granted by the Deed of Trust executed by Jose Luis Rubio and Herendira Martinez.

The real property and personal property encumbered by the Deed of Trust will be sold at the sale in accordance with the provisions of the Deed of Trust and as permitted by Section 9.604(a) of the Texas Business and Commerce Code.

6. *Obligations Secured.* The Deed of Trust provides that it secures the payment of the indebtednesses and obligations therein described (collectively, the "Obligations") including but not limited to (a) Note in the original principal amount of \$200,000.00, executed by Jose Luis Rubio and Herendira Martinez, and payable to the order of Robert John Crowell, and (b) all renewals and extensions of the Note. Robert John Crowell is the current holder of the Obligations and is the Beneficiary under the Deed of Trust.


As of April 9, 2025, there was owed \$227,447.48 plus interest which has accrued under the terms of the Note, late fees and reasonable attorney fees reimbursable to the current holder under the Note and/or Deed of Trust and the delinquent ad valorem real property taxes for the year 2024.

In addition, all of Beneficiary's claims, demands, and accruals regarding the Obligations as defined in this Notice, whenever made, and whether for principal, interest, or otherwise, are intended to comply in all respects, both independently and collectively, with all applicable usury laws, and are accordingly limited so that all applicable usury laws are not violated.



Being a tract of land situated in the George Pollett Survey, Abstract No. 821 and in the W. B. Humphreys Survey, Abstract No. 1335, Hunt County, Texas, and being part of a 50.22 acre tract of land conveyed to Stacey Smith by deed recorded in Volume 1384, Page 567, Official Public Records, Hunt County, Texas, and being more particularly described as follows:

Commencing at a 3/8" iron pin found on the south line of Countess Country - Phase One, an addition to Hunt County, Texas, according to the plat thereof recorded in Volume 400, Page 992, Plat Records, Hunt County, Texas and for the northeast corner of said 50.22 acre tract and the northwest corner of a 34.82 acre tract of land conveyed to Capital Limousine Service, Inc. by deed recorded in Volume 1594, Page 287, Official Public Records, Hunt County, Texas; Thence, South 01°44'05" East, along the east line of said 50.22 acre tract and the west line of said 34.82 acre tract, a distance of 847.18 feet to a 1/2" iron pin set with yellow cap stamped "CCG INC RPLS 5129" for the Point of Beginning;

Thence, South 88°20'49" West, a distance of 1289.74 feet to a mag nail set for corner in the center of County Road No. 3602, on the west line of said 50.22 acre tract and on the east line of a tract of land conveyed to Billy Green by deed recorded in Document No. 2015-13131, Official Public Records, Hunt County, Texas;

Thence, North 01°39'11" West, along the center of County Road No. 3602, the west line of said 50.22 acre tract and the east line of said Green tract, a distance of 508.50 feet to a mag nail set for corner;
