

An election is hereby ordered to be held on May 7, 2022, in Hunt County, Texas for voting in a special election to adopt or reject the proposed Constitutional Amendments as submitted by the 87th Legislature, 2nd Special and 3rd Special Sessions, of the State of Texas.






County Commissioner Precinct 1
(Comisionado del Condado Precinto 1)




County Commissioner Precinct 2
