WHEREAS, on this the 30th day of August 2022, the Commissioners' Court of Hunt County Texas, convened in a PUBLIC HEARING with the following members present:

AND WHEREAS, the matter brought before the Court was the adoption of the 2022-2023 budget as required by Texas Local Government Code §111.008;

AND WHEREAS, after notice and hearing, the following motion was offered by Phillip Martin and seconded by Steven Harrison  
"I move to adopt the 2022-2023 Budget for Hunt County as presented."

The calculated tax rates for the YEAR 2022 are:

The total County debt obligation is \$12,136,698

**THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY AMOUNT OF \$2,360,255, WHICH IS A 6.53 PERCENT INCREASE FROM LAST YEAR'S BUDGET. THE PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$1,998,372.**


Thereupon, the vote being taken, the following voted for the adoption of the budget for Hunt County for Fiscal Year 2022-2023: The vote on the motion was as follows:




