




Maintenance Fund for existing Upper Sabine Soil & Water Conservation District in Hunt County and for those Hunt County sites for Floodwater Retarding Structures.

1. The County of Hunt and the Upper Sabine Soil and Water Conservation District agree to terminate the MOU previously agreed upon and filed for record on January 15, 2020 and to enter into this agreement in by executing this new document.
2. Hunt County Commissioners Court agrees to contribute \$20,000.00 per year, for five (5) years following the approval of this agreement, towards O & M. The term of this agreement shall begin January 1, 2024 and expire December 31, 2028.
3. The Upper Sabine Soil and Water Conservation District agrees to furnish the following at no cost to Hunt County:
 - all planning
 - interim inspection
 - administration assistance to request and obtain state funds
 - technical assistance necessary for maintenance of all structures
 - design
 - layout
 - inspection
 - certify installation of all improvements
4. All money contributed by Hunt County will only be expended by work order approved by the Upper Sabine Soil and Water Conservation District.
5. Hunt County will issue funds at the beginning of their fiscal year.
6. This agreement will remain in force until cancelled by mutual consent of both agencies. This action was authorized at an official meeting of the Upper Sabine Soil and Water Conservation District and the Hunt County Commissioners Court.
