ORDER ADOPTING TAX RATE

THE STATE OF TEXAS §

COUNTY OF HUNT §

WHEREAS, on this the ^{27th} 23rd day of September, 2024, the Commissioners' Court of Hunt County, Texas, convened in a PUBLIC HEARING with the following members present:

- Bobby w. Stovall: County Judge
- Mark Hutchins: Commissioner, Pct. #1
- David Monroe: Commissioner, Pct. #2 *DM*
- Phillip Martin: Commissioner, Pct. #3
- Steven Harrison: Commissioner, Pct. #4 *SH*

AND WHEREAS, the matter brought before the Court was the setting of a tax rate as required by Section 26.05, Texas Tax Code;

AND WHEREAS, after notice and hearing, the following motion was offered by Commissioner Harrison and seconded by Commissioner Martin: "I move that the property tax rate be increased by the adoption of a tax rate of .323328, which is effectively a zero percent increase in the tax rate."

The tax rate for the YEAR 2024 is computed as follows:

General Fund	0.219222
R & B Fund	0.099004
Total Maintenance & Operation	0.318226
Debt Service Fund	0.005102
Total All Funds	0.323328

The above rates are per \$100 of assessed valuation.


THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY ZERO PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$ 0.00.


