This letter addresses the implementation of the Local Government Assistance Program defined under the rules TAC Title 43, Part 1, Chapter 29, Subchapter A, Rule § 29.3 (43TAC § 29.3), and the Appropriation Act passed during the 84<sup>th</sup> session of the Legislature. The rule requires the Department to give materials to the counties to assist in repairing and maintaining county roads damaged by the impact of the 2060 Weight Tolerance permits.

The FY2025 assistance allotment for Hunt County is \$31,104. Please see attached a list of Available Material by County for the Paris District for the FY2025 program. It is possible for your county to obtain materials that are shown on the attached spreadsheet that are located in counties other than your own. 
