## AN ORDER OF THE COMMISSIONERS COURT OF HUNT COUNTY, TEXAS GRANTING THE DISCRETIONARY EXEMPTION TO THE COMPETITIVE BIDDING REQUIREMENTS OF SECTION 262 OF THE TEXAS LOCAL GOVERNMENT CODE FOR ITEMS PURCHASED FOR THE CONSTRUCTION OF THE P25 PUBLIC SAFETY RADIO SYSTEM AND SETTING AN EFFECTIVE DATE.

WHEREAS, the Commissioners Court of Hunt County, Texas approved the creation and implementation of a new public safety radio system in September 2022; and

WHEREAS, the County's radio program consultant has determined that the best available option for the County for a new public safety radio system is that available from L3Harris; and

WHEREAS, as the County always endeavors to abide by the competitive bidding requirements of Section 262 of the Texas Local Government Code for County purchases, it is necessary for the Commissioners Court to grant a discretionary exemption allowed under Section 262.024(a)(2) for the purchase of additional Police and Fire radios from L3Harris; and

**WHEREAS,** the exemption is necessary for the necessary acquisition by the County of additional Police and Fire radios from L3Harris;

### BE IT ORDAINED BY THE COMISSIONERS COURT OF HUNT COUNTY, TEXAS:

Section 1. Findings. The statements contained in the preamble to this Ordinance are true and correct and are hereby adopted as findings of fact and as part of the operative provision hereof.

<u>Section 2. Approval.</u> The approval of this ordinance as evidence by the signatures below grants, by order of the Hunt County Commissioners Court, the discretionary exemption for the Court to purchase additional Police and Fire radios from L3Harris necessary to preserve or protect the public health or safety of the residents of the County as listed in the preamble to this Ordinance.


