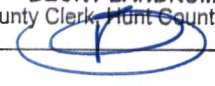

AND WHEREAS, the matter brought before the Court was the adoption of the 2024-2025 budget as required by Texas Local Government Code Sec. 111.008;

AND WHEREAS, after notice and hearing, the following motion was offered by Monroe and seconded by Hutchins: "I move to adopt the 2024-2025 Budget for Hunt County as presented."

The calculated tax rates for the YEAR 2024 are:

The total County debt obligation is \$10,722,603.84

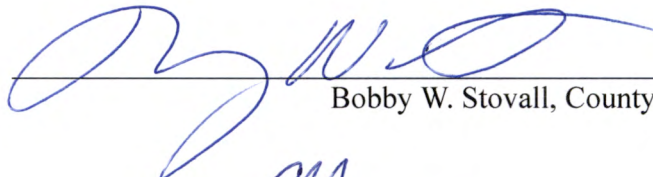
THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY AN AMOUNT OF \$2,670,509 WHICH IS A 6 PERCENT INCREASE FROM LAST YEAR'S BUDGET. THE PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$2,281,687.

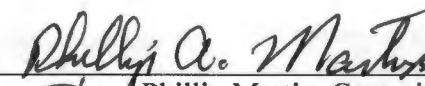

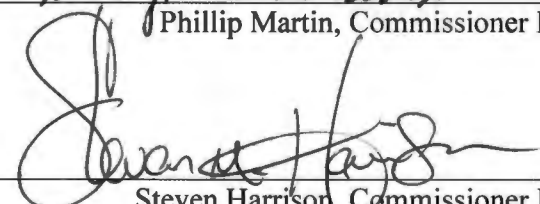
