**INTERLOCAL COOPERATION AGREEMENT BETWEEN HUNT COUNTY, TEXAS  
AND THE CITY OF WOLFE CITY FOR THE REPAIR OF A ROAD**

This agreement ("**Agreement**") is made and entered into between **Hunt County, Texas** ("**COUNTY**"), a political subdivision of the State of Texas, and **the City of Wolfe City, Texas** ("**Wolfe City**"), a political subdivision of the State of Texas located in Hunt County. Where appropriate, the County and Wolfe City are collectively described in this Agreement as the "**Parties.**" This agreement will be effective as soon as it is approved by the governing body of the Parties and signed by the Mayor of Wolfe City and the Hunt County Judge.

**RECITALS**

Whereas, the Parties mutually desire to enter into this Agreement for the purpose of providing for the repair of a rock road known as "**Wastewater Road**" in accordance with the terms provided herein;

Whereas, this Agreement is made pursuant to the authority granted to the Parties by the Interlocal Cooperation Act, Texas Government Code Chapter 791 (the "**Act**");

Whereas, the repair of the Wastewater Road under this agreement is for the purpose of providing for the health, safety and welfare of the public;

**NOW, THEREFORE**, in consideration of the mutual covenants, promises, and agreements expressed herein, the Parties agree as follows:

**AGREEMENT**

**1. Scope of Agreement.**

The County shall, through its own employees and using its own materials, repair the Wastewater Road to a condition as to render it capable carrying equipment necessary for the repair of Wolfe City's water treatment plant.

**2. Payment for Services.**


Wolfe City shall reimburse the County for the cost of both employee time and materials used in the repair of the Wastewater Road after receipt of an invoice from the County for the cost of repairs.


