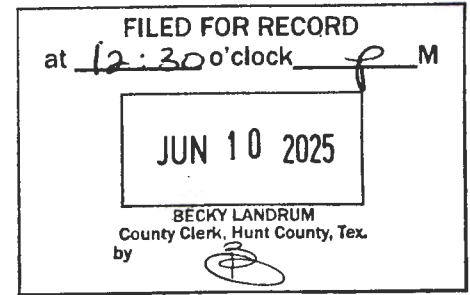

ESCROW TRUST AGREEMENT

THE STATE OF TEXAS
COUNTY OF HUNT COUNTY

This contract and agreement made and entered into on this the 21st day of May 2025, by and between Hunt County Commissioner Steven Harrison, Precinct 4, and Apex Acres Holding LLC by hereinafter called "Purchaser".

That said, Purchaser has deposited into a fund labeled "County Road Improvement Fund" the amount of \$42,248.00 for the purpose of constructing a certain site improvement, to wit:

- Widening the road a width of 5 feet from dirt to rock to oil sand for an approximate length of 1,085 feet on CR 4704 for a total cost of \$13,640.00
- Widening the road a width of 5 feet from dirt to rock to oil sand for an approximate length of 2,248 feet on CR 4609 for a total cost of \$28,608.00

To be specifically used for the improvements of the said road when adequate funding becomes available. The cost of said improvements shall be prepared by the Commissioner and agreed upon by the purchaser prior to the execution of this agreement. Upon receipt of payment, the County Treasurer shall forward a copy of the deposit warrant to the commissioner in charge of making said improvements. If for any reason the county has not completed said improvement within one hundred twenty (120) days from the date of execution of this agreement, the escrowed road improvement funds shall, at the request of the said purchaser, be returned to the purchaser and this agreement shall then become void.

WHEREAS, said improvement is left to the sole discretion of the responsible commissioner.

IN TESTIMONY WHEREOF, the parties hereto have executed this contract and agreement on this the 21st day of May, 2025.
