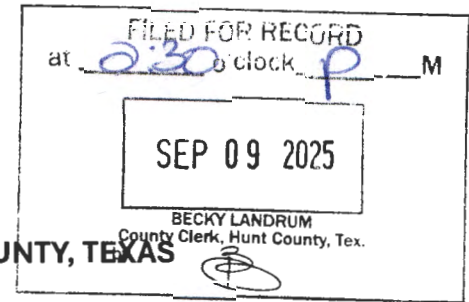

ORDER ADOPTING TAX RATE

ORDER OF THE COMMISSIONERS COURT OF HUNT COUNTY, TEXAS

Adopting the 2025 Property Tax Rate



WHEREAS, the Hunt County Tax Assessor-Collector has submitted the calculations of the no-new-revenue tax rate, the no-new-revenue maintenance and operations rate, the voter-approval rate, and the debt rate for 2025 in accordance with Chapter 26 of the Texas Tax Code; and

WHEREAS, the Commissioners Court has provided all required notices and conducted a public hearing in compliance with the Texas Property Tax Code;

NOW, THEREFORE, BE IT ORDERED by the Commissioners Court of Hunt County, Texas, that:

1. The property tax rate for Hunt County for the tax year 2025 (fiscal year 2025–2026) is set at:
 - **Adopted Rate:** \$0.333241 per \$100 valuation
 - **No-New-Revenue Rate:** \$0.325741 per \$100 valuation
 - **No-New-Revenue M&O Rate:** \$0.228822 per \$100 valuation
 - **Voter-Approval Rate:** \$0.376740 per \$100 valuation
 - **Debt Rate:** \$0.005359 per \$100 valuation
2. **Required Statements under Tax Code §26.05:**
 - *THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.*
 - *THE TAX RATE WILL EFFECTIVELY BE RAISED BY 2.30% AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$7.50.*
3. The adoption of this tax rate was made by separate record vote from the adoption of the budget, as required by law.

Motion Required by Law (Tax Code §26.05(b)):

"I move that the property tax rate be increased by the adoption of a tax rate of \$0.333241, which is effectively a 2.30% increase in the tax rate."
