**ORDER SETTING PUBLIC HEARING ON PETITION TO CREATE
HUNT COUNTY EMERGENCY SERVICES DISTRICT NO. 2**

WHEREAS, Chapter 775 of the Texas Health and Safety Code authorizes the creation of an emergency services district to provide emergency services under Article III, Section 48-e of the Texas Constitution;

WHEREAS, a petition has been presented to the County Judge of Hunt County, Texas, requesting the creation of an emergency services district to be known as Hunt County Emergency Services District No. 2;

WHEREAS, the proposed district is described in the petition and is proposed to provide emergency services within the territory described in the petition;

WHEREAS, the County has reviewed the petition for purposes of determining whether the petition contains the number of signatures required by Section 775.011 of the Texas Health and Safety Code, and the County has confirmed that the petition includes the required number of qualified voters who own taxable real property in the proposed district;

WHEREAS, the petition has been reviewed for statutory form under Chapter 775 of the Texas Health and Safety Code, including Sections 775.011, 775.013, 775.014, and 775.0205, to the extent applicable, for purposes of setting the public hearing required by Section 775.015;

WHEREAS, if any territory described in the petition is located within the limits or extraterritorial jurisdiction of a municipality, Chapter 775 requires the County to address municipal consent or exclusion issues before any territory may be included in the proposed district as provided by Section 775.014;

WHEREAS, Section 775.015(a) of the Texas Health and Safety Code provides that, if the petition is in proper form, the County Judge may receive the petition and shall file the petition with the County Clerk;

WHEREAS, Section 775.015(b) of the Texas Health and Safety Code provides that, at the next regular or special session of the Commissioners Court held after the petition is filed with the County Clerk, the Commissioners Court shall set the place, date, and time for the hearing to consider the petition;

WHEREAS, Section 775.015(c) of the Texas Health and Safety Code requires the County Clerk to give notice of the hearing, including notice that creation of a district is proposed, that the district is to be created and operated under Article III, Section 48-e of the Texas Constitution, the name of the proposed district, the district boundaries as stated in the petition, the place, date, and time of the hearing, and the right of interested persons to attend the hearing and present grounds for or against creation of the district;

WHEREAS, Section 775.015(d) and (e) of the Texas Health and Safety Code require the County Clerk to retain a copy of the notice and deliver sufficient copies to the Sheriff for posting

and publication, and require the Sheriff, not later than the 21st day before the hearing date, to post one copy of the notice at the courthouse door and to have the notice published in a newspaper of general circulation in the proposed district once a week for two consecutive weeks, with the first publication occurring not later than the 21st day before the hearing date; and

WHEREAS, the Commissioners Court desires to set a public hearing on the petition, direct the issuance and publication of notice, and authorize County officials to take the actions necessary to process the petition under Chapter 775.

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT OF HUNT COUNTY, TEXAS, THAT:


1. The Commissioners Court finds that the recitals stated above are true and correct and incorporates those recitals into this Order as findings of the Commissioners Court.
2. The Commissioners Court acknowledges receipt and filing of the petition requesting creation of Hunt County Emergency Services District No. 2 under Chapter 775 of the Texas Health and Safety Code. This Order is entered for the limited purpose of setting and noticing the public hearing required by Section 775.015 and does not constitute final approval of the petition, creation of the proposed district, approval of the proposed boundaries, or an order calling an election.
3. The Commissioners Court sets a public hearing to consider the petition for creation of Hunt County Emergency Services District No. 2 as follows:

Date:	July 7, 2024
Time:	6:00 P.M.
Place:	Hunt County Commissioners Courtroom, Hunt County Courthouse, Greenville, Texas

4. At the public hearing, the Commissioners Court shall consider the petition and each issue relating to creation of the proposed district. Interested persons may appear in person or by attorney to support or oppose creation of the proposed district and may offer pertinent testimony.
5. The County Clerk is directed to prepare and give notice of the public hearing in the manner required by Section 775.015 of the Texas Health and Safety Code. The notice shall substantially conform to the form attached to this Order as Exhibit A, with such conforming revisions as the County Judge, County Clerk, County Civil Attorney, or their designees determine are necessary to accurately reflect the petition, the proposed boundaries, the hearing information, and Chapter 775.
6. The County Clerk shall retain a copy of the notice and shall deliver sufficient copies of the notice to the Hunt County Sheriff for posting and publication as prescribed by Section 775.015(d) and (e) of the Texas Health and Safety Code.


7. The Hunt County Sheriff is directed, not later than the 21st day before the hearing date, to post one copy of the notice at the courthouse door and to have the notice published in a newspaper of general circulation in the proposed district once a week for two consecutive weeks, with the first publication occurring not later than the 21st day before the hearing date.
8. The return of each officer executing notice shall be endorsed on or attached to a copy of the notice, shall show the execution of the notice, shall specify each date on which the notice was posted or published, and shall include a printed copy of the published notice, as required by Section 775.015(f) of the Texas Health and Safety Code.
9. The County Civil Attorney, County Clerk, Elections Administrator, County Judge, Sheriff, and other appropriate County officials are authorized and directed to take all actions reasonably necessary or appropriate to process the petition, coordinate required notice, evaluate any municipal-consent or exclusion issues under Section 775.014 of the Texas Health and Safety Code, and present the matter for hearing and further action by the Commissioners Court.
10. All prior actions of County officials consistent with this Order are ratified and approved.

NOTICE OF PUBLIC HEARING
CONCERNING THE PROPOSED CREATION OF
HUNT COUNTY EMERGENCY SERVICES DISTRICT NO. 2

TO ALL PERSONS INTERESTED:

Notice is hereby given pursuant to Section 775.015 of the Texas Health and Safety Code that creation of an emergency services district is proposed in Hunt County, Texas. The proposed district is to be known as Hunt County Emergency Services District No. 2.

The proposed district is to be created and to operate under Article III, Section 48-e of the Texas Constitution and Chapter 775 of the Texas Health and Safety Code.

The boundaries of the proposed district are as stated in the petition filed with the Hunt County Clerk. A copy of the petition, including the description of the proposed district boundaries, is available for public inspection in the office of the Hunt County Clerk during regular business hours.

A public hearing on the petition to create Hunt County Emergency Services District No. 2 will be held as follows:

Place:	Hunt County Auxiliary Courtroom, 2700 Johnson Street, Greenville, Texas
