 - C. Material to be used on this project: **Hot Mix Asphalt**

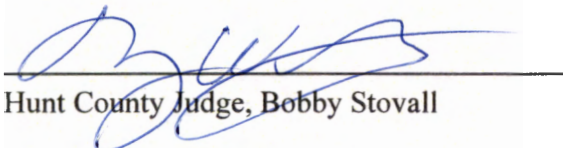
